On behalf of my company, I consent and submit to the venue and jurisdiction selected by PCB Prime and to the application of the law of the state in which the action is brought. Collection agency fees not to exceed 35% shall be paid by my company. PCB Prime shall also be entitled to its reasonable attorney's fees and actual cost for post-judgment collection. My company will be liable for interest on past due accounts at a per annum rate which may vary up to the maximum allowed by the law. For the Continental USA and Hawaii interest will be 18% simple interest per annum.
